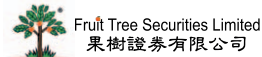

## ANNOUNCEMENT OF OFFER PRICE AND ALLOTMENT RESULTS

### SUMMARY

#### Offer price and net proceeds from the Global Offering

- The Offer Price has been determined at HK\$0.98 per Offer Share (excluding brokerage of 1%, the SFC transaction levy of 0.0027% and the Stock Exchange trading fee of 0.005%).
- Based on the Offer Price of HK\$0.98 per Offer Share, the net proceeds from the Global Offering to be received by the Company after deduction of underwriting fees and commissions and other estimated expenses payable by the Company in connection with the Global Offering, are estimated to be approximately HK\$61.1 million. The Company intends to use the net proceeds from the Global Offering in the manner as set out in the paragraph headed “Net Proceeds from the Global Offering” below.

#### Applications under the Hong Kong Public Offering

- The Offer Shares initially offered under the Hong Kong Public Offering have been moderately over-subscribed. A total of 9,794 valid applications have been received pursuant to the Hong Kong Public Offering on **WHITE** and **YELLOW** Application Forms and through giving **electronic application instructions** to HKSCC via CCASS and to the **HK eIPO White Form** Service Provider through the **HK eIPO White Form** service for a total of 250,860,000 Hong Kong Offer Shares, equivalent to approximately 19.30 times of the total number of 13,000,000 Hong Kong Offer Shares initially available for subscription under the Hong Kong Public Offering.
- As the over-subscription in the Hong Kong Public Offering is 15 times or more but less than 50 times, the reallocation procedure as described in the section headed “Structure of the Global Offering — The Hong Kong Public Offering — Reallocation” in the Prospectus has been applied. 26,000,000 Offer Shares have been reallocated to the Hong Kong Public Offering from the International Offering. As a result of the reallocation, the final number of Offer Shares allocated to the Hong Kong Public Offering is 39,000,000 Offer Shares, representing 30% of the total number of Offer Shares initially available under the Global Offering.

## International Offering

- The Offer Shares offered under the International Offering have been moderately over-subscribed. The Joint Global Coordinators confirmed that there was no over-allocation of the Offer Shares in the International Offering. The final number of Offer Shares under the International Offering is 91,000,000 Shares, representing 70% of the total number of the Offer Shares initially available under the Global Offering (before exercise of the Over-allotment Option). A total of 91,896,000 International Offer Shares have been subscribed, representing approximately 1.01 times of the total number of 91,000,000 International Offer Shares. A total number of six, 39, 58 and 94 places has been allotted ten, 30, 50 and 100 board lots of Shares or less, representing approximately 4.1%, 26.9%, 40.0% and 64.8% of total number of places under the International Offering, respectively. These places have been allotted approximately 0.26%, 3.8%, 7.8% and 17.2% of the Offer Shares under the International Offering, respectively.

## **NET PROCEEDS FROM THE GLOBAL OFFERING**

Based on the Offer Price of HK\$0.98 per Offer Share, the net proceeds from the Global Offering to be received by the Company, after deducting the underwriting fees and commissions and other estimated expenses payable by the Company in connection with the Global Offering, are estimated to be approximately HK\$61.1 million. The Company currently intends to apply such net proceeds in accordance with the purposes set out in the section headed “Future plans and use of proceeds” in the Prospectus, as follows:

Further, each Cornerstone Investor has agreed not to, without the prior written consent of the Company and the Joint Global Coordinators, whether directly or indirectly, at any time during the period of six months following the Listing Date (the “**Lock-up Period**”), dispose of any of the Shares purchased pursuant to the relevant cornerstone

investment agreements or any interest in any company or entity holding any of the relevant Shares, save for certain limited circumstances, such as transfers to any of his/her wholly-owned subsidiaries provided that such transferee agrees to be subject to the terms and restrictions imposed on such Cornerstone Investor, including the Lock-up Period restriction specified in the relevant cornerstone investment agreements. Please refer to the section headed “Cornerstone Investors” in the Prospectus for further details relating to the Cornerstone Investors.

None of the Sole Sponsor, the Joint Global Coordinators, the Joint Bookrunners, the Joint Lead Managers, the Underwriters and their respective affiliated companies and connected clients of the lead broker or of any distributors (as defined in Appendix 6 to the Listing Rules) has taken up any Offer Shares for its own benefit under the Global Offering. The Directors confirm that no Offer Shares under the International Offering have been allocated to applicants who are (i) core connected persons (as defined in the Listing Rules) of the Company, (ii) directors or existing shareholders or existing beneficial owners or their respective close associates (as defined in the Listing Rules) of the Company and/or any of the Company’s subsidiaries or (iii) their respective close associates (as defined in the Listing Rules) of (i) and/or (ii) above, whether in their own names or through nominees. The International Offering has been conducted in compliance with the Placing Guidelines and no Offer Shares placed by or through the Joint Global Coordinators and the Underwriters under the Global Offering have been placed with any core connected person (as defined in the Listing Rules) of the Company, or persons set out in paragraph 5 of the Placing Guidelines, whether in their own names or through nominees. No placee will, individually, be placed more than 10% of the total number of issued shares of the Company immediately after the Global Offering. None of the placees under the International Offering will become a substantial shareholder (as defined in the Listing Rules) of the Company after the International Offering.

## **PUBLIC FLOAT**

The Company confirms that immediately following completion of the Global Offering, the number of issued Shares in the hands of the public will represent at least 25% of the total number of issued Shares and will satisfy with the minimum percentage prescribed by Rule 8.08 of the Listing Rules. The Directors confirm that the three largest public Shareholders do not hold more than 50% of the Shares held in public hands at the time of the Listing in compliance with Rules 8.08(3) and 8.24 of the Listing Rules. The Directors also confirm that there will be at least 300 Shareholders at the time of the Listing in compliance with Rule 8.08(2) of the Listing Rules.

## OVER-ALLOTMENT OPTION

The Company has granted the Over-allotment Option to the International Underwriters exercisable by the Joint Global Coordinators on behalf of the International Underwriters at any time from the date of the Listing Date until the 30th day after the last date for the lodging of the applications under the Hong Kong Public Offering, to require the Company to issue and allot up to 19,500,000 additional Shares, representing in aggregate 15% of the Shares initially being offered under the Global Offering, at the Offer Price to cover over-allocations in the International Offering, if any. The Joint Global Coordinators confirmed that there was no over-allocation of the Offer Shares in the International Offering. Therefore, the Over-allotment Option will not be exercised.
